7) Announcement of SENMC President: Sarah Bowman made a motion to select Dr. Kevin Beardmore as President of SENMC and authorize the Board Chair to approve and execute a contract containing the following points: a) three-year term with annual salary of \$200,000, b) a \$1,200 monthly housing allowance, once Dr. Beardmore purchases and closes on a personal residence in Carlsbad or in the immediate surrounding area, c) relocation expenses up to \$12,000, the amount of relocation expenses may be adjusted upward if needed at the discretion of the Board Chair, d) if needed temporary housing with utilities paid for a period of 90 days to allow Dr. Beardmore to locate and set up his permanent residence, e) provisions for a paid cell phone, WiFi, and such other customary and reasonable items and benefits suitable and adequate for performance of his duties as President, and f) such additional terms and conditions as advised by Legal Counsel.
